ORDINANCE NO. 11-O-04
BUDGET FY 2011-2012

1 **AN ORDINANCE CONCERNING THE CITY OF ABERDEEN FY 2011-2012**
2 **BUDGET FOR** the purpose of adopting the City of Aberdeen FY 2011-2012 Budget; and all
3 matters generally relating thereto.

4 **SECTION 1: BE IT ENACTED BY THE MAYOR AND CITY COUNCIL OF THE**
5 **CITY OF ABERDEEN THAT** the Budget for the City of Aberdeen for fiscal year beginning
6 1 July 2011 and ending 30 June 2012, attached hereto as Attachment 1 and incorporated herein
7 by reference, and entitled, “**City of Aberdeen, Operating and Capital Budgets, Fiscal Year**
8 **2012 (July 1, 2011 – June 30, 2012)**”, is adopted and for all purposes shall be considered the FY
9 2011-2012 Budget for the City of Aberdeen. The Budget shall include revenue and expenditures
10 for the Water Enterprise Fund, Sewer Enterprise Fund, Stadium Enterprise Fund, General Fund,
11 and all Capital Budgets related thereto.

12 **SECTION 2: BE IT FURTHER ENACTED THAT** the FY 2012 General Fund Budget
13 is based on an annual real property tax rate of \$0.6800 per \$100 of assessed value and an annual
14 personal property tax rate of \$1.70 per \$100 of assessed value.

15 **SECTION 3: BE IT FURTHER ENACTED THAT** the annual real property tax rate
16 for properties that qualify under the City of Aberdeen LEED Office Building Tax Subclass, after
17 enactment of Ordinance No. 11-O-05, shall be \$0.1700 per \$100 of assessed value.

18 **SECTION 4: BE IT FURTHER ENACTED THAT** the FY 2012 Water Use Rate
19 shall be a minimum charge of \$14.50 for the first 3,500 gallons or less and \$4.38 per each
20 additional 1,000 gallons. The Sanitary Sewer Use Rate shall be a minimum charge of \$17.02 for
21 the first 3,500 gallons or less of metered water and \$4.85 per each additional 1,000 gallons of
22 metered water.

23 **SECTION 5: AND BE IT FURTHER ENACTED THAT** this ordinance shall become
24 effective on 1 July, 2011.
