ORDINANCE NO. 12-O-03

**AMENDMENT TO THE CODE OF THE CITY OF ABERDEEN
COUNCIL LIAISONS**

1 **AN ORDINANCE** to amend the Code of the City of Aberdeen, Chapter 30, § 30-2; Chapter 61,
2 § 61-2, H. I.; and Chapter 108, § 108-2, C. by removing the requirements to maintain Council
3 liaisons as appointed members of certain Boards and Commissions.

4 **BE IT ENACTED THAT CHAPTER 30, ECONOMIC DEVELOPMENT COMMISSION,**
5 § 30-2, be and is hereby amended and to read as follows:

6 **§ 30-2. Membership; terms of office.**

7 The Commission shall be comprised of interested citizens appointed by the Mayor
8 and Council. Members may include county and state representatives and shall be
9 chosen according to their interest and expertise in economic development. The
10 Mayor and Council shall determine the number of members. ~~One Council~~
11 ~~member shall be appointed to represent the City.~~ The term of each member shall
12 be one year.

13 **BE IT ENACTED THAT CHAPTER 61, HERITAGE TRUST,** § 61-2, H. and I. be and are
14 hereby amended and to read as follows:

15 **§ 61-2. Membership and organization.**

16 ~~I. Liaison. One City Councilperson shall serve as a liaison to the Trust.~~

17 ~~J. I.~~ Resignation, removal and vacancy of members. In the event that a member
18 resigns, the Chairperson shall recommend to the Mayor and City Council a
19 qualified replacement for approval. Any member of the Trust may be removed for
20 good cause by the Mayor and City Council. Any vacancy in the membership of
21 the Trust shall be filled by the Mayor and City Council; provided, however, that

22 in the case of an unexpired term, the term of the new member shall be only for the
23 remainder of the unexpired term for which his or her predecessor was appointed.

24 **BE IT ENACTED THAT CHAPTER 108, PARKS AND RECREATION BOARD, § 108-2,**
25 C. be and is hereby deleted as follows:

26 **§ 108-2. Membership; terms of office.**

27 ~~C. One Council member shall be appointed annually to represent the City.~~

28 **LET IT BE FURTHER ENACTED**, upon motion duly made and approved by the Mayor and
29 Council, the above Ordinance is hereby adopted and shall be effective at the expiration of twenty
30 (20) calendar days after date of the adoption.
