**A RESOLUTION OF THE CITY OF ABERDEEN FOR THE PURPOSE OF
SUPPORTING AND ACKNOWLEDGING THE SUSTAINABLE MARYLAND
CERTIFIED MUNICIPAL CERTIFICATION PROGRAM**

1 **WHEREAS**, a sustainable community means meeting the needs of the present without
2 compromising the ability of future generations to meet their own needs.

4 **WHEREAS**, a sustainable community seeks to optimize quality of life for its residents by
5 ensuring that its environmental, economic and social objectives are balanced and mutually
6 supportive; and

8 **WHEREAS**, the City of Aberdeen strives to save tax dollars, assure clean land, air and water,
9 improve working and living environments as steps to building a sustainable community that will
10 thrive well into the new century; and

12 **WHEREAS**, the City of Aberdeen hereby acknowledges that the residents of the City of
13 Aberdeen desire a stable, sustainable future for themselves and future generations; and

15 **WHEREAS**, the City of Aberdeen wishes to support a model of government which benefits our
16 residents now and far into the future by exploring and adopting sustainable, economically-sound,
17 local government practices; and

19 **WHEREAS**, by endorsing a sustainable path, the City of Aberdeen is pledging to educate itself
20 and community members further about sustainable activities and to develop initiatives
21 supporting sustainable local government practices; and

23 **WHEREAS**, as elected representatives of the City of Aberdeen, we have a significant
24 responsibility to provide leadership which will seek community-based sustainable solutions to
25 strengthen our community.

26 **NOW THEREFORE, BE IT RESOLVED**, that to focus attention and effort within the City of
27 Aberdeen on matters of sustainability, the Mayor and City Council wish to pursue local
28 initiatives and actions that will lead to Sustainable Maryland Certified Municipal Certification.

30 **BE IT FURTHER RESOLVED**, by the Mayor and City Council of the City of Aberdeen that
31 we do hereby authorize Mayor Michael E. Bennett to serve as the City of Aberdeen's agent for
32 the Sustainable Maryland Certified Municipal Certification process and authorize him to
33 complete the Municipal Registration on behalf of the City of Aberdeen.




